February Meeting Plans – Your new officers will take charge at the February meeting; see the masthead above for the 2007 LARG Officers elected at the January meeting.

Your 2007 dues were due in January, but it's still not too late to pay up! For your convenience, we have again this month attached a copy of the LARG club membership application at the end of the newsletter. You can just print that page and bring it to the February meeting with you or just mail it to our new Treasurer (address is at the top of the application).

Contesting News – We are still in the midst of the winter contest season; "...When the weather outside is frightful, 40 meters can be so delightful...". You can get warmed up for the Virginia QSO Party by working one, two, or three state QSO Parties the first weekend in February. You can get the details of the Minnesota QP at http://www.w0aa.org; for the Delaware QP go to http://www.fsarc.org; and for the Vermont QP visit their web site at http://www.qsl.net/w1bd. These smaller state QSO Parties are an excellent way to get practice for other contests such and for the Virginia QP.

The big DX contest(s) coming up in February and March are the ARRL CW and SSB DX contests. The CW version is the weekend of February 17-18, and the SSB contest is held the weekend of March 3-4. In this DX contest W/VE hams work DX stations around the world; the DX amateurs can only work W/VE stations. The exchange is simply a signal report and your state/province. Of course, the contest that everyone in the club can enjoy and take part in is the Virginia QSO Party, the weekend of March 17-18. The VAQP starts Saturday afternoon after the LARG March club meeting. Our club has had a long tradition of participation in this QSO Party, and in spite of its somewhat arcane and peculiar rules, club members have done well individually and the club has done outstandingly well collectively by winning the Virginia Club category in the past. Other state QSO Parties, such as the Pennsylvania QSO Party are more fun to participate in for both in-state and out-of-state hams because they have more reasonable operating times, emphasize working US and Canadian hams, and eliminate the temptation for in-state participants to work DX stations who are operating in other contests. However, the VAQP is our own state QSO Party, and we have to take what we can get.

Also, because apparently SPARC does not count hand-written logs towards the in-state club competition for working the most in-state stations, the contest committee will make an effort this year to manually type in the hand-written logs from our members before we submit them to SPARC.

As far as my records go, 1997 was the first year we participated as a club in the VAQP. Using my own data and the excellent summaries for the VAQP that Norm, **AI2C**, has put on the K4LRG website (see http://www.k4lrg.org/Contests/DX Contest Links.htm and scroll near the bottom of the page) I have put together the following data for LARG's participation in the VAQP as a club. The increases in the total club score is interesting, but the way in which the number of participants has increased is even more important, to my way of thinking, at least. It looks like LARG has contributed between 10% and 20% of all the in-state logs over the years and typically has more than 75% of the mobile operations.

New Business

Jay Greeley reported that the Virginia Defense Force (our state militia and the auxiliary to the National Guard) is

currently expanding its ranks to cover Guard activities, with so many Guard units deployed to Iraq. He suggested that LARG explore ways that they can assist the VDF by providing communications training for those individuals who will be using the Comm Van.
